The Embassy of the United States of America, Paramaribo is seeking a contractor or firm to perform, **Restoration work of the CCAC decking and drainage** at the Embassy at Kristalstraat 165, Morgenstond Paramaribo – Suriname.

The project is described as “CCAC Resysta decking and drainage repair work”. The CCAC entrance walkway decking is constructed with Resysta boards. Due to improper installation and treatment, multiple gaps between boards and uneven surface occurs which is a potential tripping hazard. All Resysta decking is to be replaced with same tinted color concrete paving bricks. All replacement materials should be sustainable and locally purchased to minimize the execution period and availability of replacement materials. The repair work is not limited to installing concrete curbs, gutters, trench drains to improve drainage of storm water on the decking as necessary by installing additional drain system to prevent water running over the sidewalk near the Kristal street (CCAC) Corner connecting to the storm drain pit near the walkway.

The Contractor shall furnish all necessary materials, labor, transportation, equipment, investigation, design and supervision. All work will be performed within in firm fixed-price contract.
